Procedure

- Add VERSENE[™] Na₂ Crystals into water and heat to 70°C using a water bath.
- Disperse the hydroxyethyl cellulose into the water and mix until homogenous. To speed dispersion, add two drops of NaOH (18% in water solution) and mix for five minutes.
- 3. Add glycerin with gentle mixing.
- In a separate vessel, combine phase B ingredients and mix. Heat to 70°C using a water bath. Continue mixing until all ingredients are completely dissolved.
- Add phase A to phase B. Maintain enough heat to keep the wax melted. Stir until homogeneous.
- 6. Cool to room temperature while gently mixing.
- One at a time in the order listed, add phase C ingredients, mixing well after each addition.
- 8. With the citric acid (25% solution in water), adjust the pH to 4.5-5.
- Add the customized silicone elixir in post addition with a wood spatula.
